NJ CELs: - NJEDA

Reduced interest rate co-lending program for small businesses (<750 employees) seeking to finance clean energy projects or working capital for clean energy-related businesses

Large Energy Users Program - NJBPU

Designed to promote self-investment in energy efficiency for eligible projects in the State's largest non-hospital commercial and industrial facilities
